## Sunderland City Council ECO4 and Great British Insulation Scheme Flexible Eligibility Statement of Intent

This statement sets out Sunderland City Council's flexible eligibility criteria for the Energy Company Obligation (ECO 4) and Great British Insulation Schemes, which run until March 2026.

The ECO4 scheme will focus on supporting low income and vulnerable households. The scheme will improve the least energy efficient homes helping to meet the Government's fuel poverty and net zero commitments. The Great British Insulation Scheme will support the ECO4 scheme in the delivery of predominantly single measures targeted at a wider range of households.

The flexible approach for Local Authorities (LAs) to identifying fuel poor and vulnerable households who may benefit from heating and energy saving measures is referred to as "ECO4 Flex" and "Great British Insulation Scheme Flex".

The Council welcomes the introduction of the ECO4 and Great British Insulation Scheme Flex eligibility routes as it helps the Council improve its low carbon commitments and achieve its plans to improve the homes of those in fuel poverty or vulnerable to the cold.

The Council is publishing this Statement of Intent (SoI) to confirm that each of the households declared will adhere to at least one of the four available routes outlined below:

All potentially eligible households should apply through the energy supplier(s) or their approved contractor(s) as appointed by Sunderland City Council to ensure that they can either benefit from the scheme or be assessed for eligibility under any other relevant programme.

Sunderland City Council has appointed E.ON Energy Solutions Ltd. and Utilita Home Ltd as partners to deliver ECO4 and Great British Insulation Scheme and can only approve applications made through these suppliers.

Eligible applicants do not need to be customers of E.ON Energy Solutions and Utilita Home to benefit from the ECO4 and Great British Insulation Scheme via these suppliers.
