# Localism Act 2011: Community Right to Bid

You will need to complete this application form if you wish to nominate an Asset of Community Value for listing. The responses to the questions in your application will enable the Council to reach a decision about your nomination. In the event that the information you supply is insufficient to make a decision, your application will be rejected.

# Nomination of an Asset

You will be required to include in your nomination form information which explains and supports the reason why you consider the land is of community value. The reason why you consider the land is of value must comply with the regulations set out in the Assets of Community Value (England) Regulations 2012.

Successful nominations will result in the asset being included in the published Register of Assets of Community Value (the List), the Asset will be removed from the list after 5 years (if not already removed).

# **Definition of Assets of Community Value**

Section 88 of the Localism Act states that the asset will be considered to be one of community value if:

- a) Its actual current use furthers the social wellbeing and interests of the local community, or a use in the recent past has done so (recent past is considered to be 5 years)
- b) that use is not an ancillary one; and
- c) for land in current community use it is realistic to think that there will continue to be a use which furthers social wellbeing and interests, or for land that has been in community use in the recent past, it is realistic to think that there will be community use within the next five years and
- d) it does not fall within one of the exemptions.
