Introduction

The Town and Country Planning (Local Planning) (England) Regulations 2012, requires that "Before a local planning authority adopt a supplementary planning document it must a) prepare a statement setting out:

- i. the persons the local planning authority consulted when preparing the supplementary planning document;
- ii. a summary of the main issues raised by those persons; and
- iii. how those issues have been addressed in the supplementary planning document.

This Consultation statement sets out details of the consultation Sunderland City Council has undertaken in the preparation of Homes in Multiple Occupation (HMO) Supplementary Planning Document (SPD).

What is the Homes in Multiple Occupation Supplementary Planning Document

SPDs add further detail to the policies in development plans. They can be used to provide further guidance for development on specific sites, or on particular issues, such as design. SPDs are capable of being a material consideration in planning decisions but are not part of the development plan.

Sunderland's Local Plan consists of three development plans, the Core Strategy and Development Plan (CSDP) (adopted 2020), the Allocations and Designations Plan (emerging) and the International Advanced Manufacturing Park (IAMP) Area Action Plan.

The HMO SPD provides further guidance how CSDP policy H6 will be delivered.

H6 Homes in Multiple Occupation (HMOs)

Development for HMOs should ensure that:

- 1. the property is located where increased traffic and activity would not be detrimental to local amenity;
- 2. the intensity of use would not adversely affect the character and function of the locality;
- 3. the proposal would not be detrimental to the amenities of neighbouring properties by causing undue noise and disturbance;
- 4. adequate provision for parking, servicing, refuse, recycling arrangements and the management and maintenance of the property can be demonstrated through the submission of a management plan;
- 5. the proposal would not result in an over concentration of HMOs within the locality; and
- 6. the accommodation provides a good standard of living space and amenity for occupiers of the HMO.

Consultation on the HMO SPD

The Council, in accordance with the Statement of Community Involvement, has undertaken two rounds of consultation on the SPD.

Stage 1 – Scoping Report	February – March 2020
Stage 2 – Draft HMO SPD	September – October 2020

Persons the local planning authority consulted when preparing the supplementary planning document

The Council wrote to all persons on the Local Plan Database, this includes statutory consultees, general consultation bodies and those who had previously expressed an interest in the Local Plan. Copies of the correspondence inviting persons to make representations on the SPD is included in Appendix 1.

Consultation at each stage

Stage 1: Consultation at Scoping Stage

The HMO SPD Scoping Report was made publicly available for comment for 4 weeks between 24 February – 30 March 2020 (Appendix 1). The SPD was made available on the Council's website¹, on the Council's online consultation portal², at Sunderland Civic Centre and libraries (in Sunderland's City Library @ Museum & Winter Gardens, Washington Galleries and Houghton-le-Spring).

Stakeholders were invited to make representations electronically via the Council's online consultation portal (<u>http://sunderland-consult.limehouse.co.uk/portal</u>) and in writing by email <u>(planningpolicy@sunderland.gov.uk</u>) or letter.

A total of 2 representations were received in response to the scoping report consultation. In summary these related to additional pressures on the highway network resulting from HMO development.

All representation were taken into consideration when preparing the Draft SPD.

Stage 2 Consultation on the Draft HMO SPD

Public consultation on the Draft HMO Supplementary Planning Document took place over a four week period, commencing on 21 September 2020 to 19 October 2020.

The consultation on the draft SPD consultation included writing to all consultee in the Local Plan database (Appendix 1) publishing the SPD and supporting documents on the council's website³ and making available to view the SPD at Sunderland Civic Centre between the hours of 8.45am-5.15pm Monday-Thursday and 8.45am-4.45pm Friday. A statement of representation procedure was published within the correspondence sent out on the Council's website. The Statement detailed when representations could be made, the deadline for making representations, how consultees could make representations, where and at what times consultation documents were available for the public and interested parties to view.

In total five representations were received. Two representations provided no comments on the substance of the HMO SPD. One representation relates to sewage infrastructure in the vicinity of Sunderland Riverside area and thus was not relevant to the HMO SPD. Another representation requested that the terms 'exceptional circumstances' and 'other material considerations' as it relates to HMO planning applications are defined within the body of the SPD. In addition, a representation expressed that the term 'satisfactory evidence' was not sufficiently defined.
